#### INVESTING IN CEE: **INBOUND M&A REPORT 2019/2020**

#### 19th March 2020 Mazars Vietnam

The M&A market in Central and Eastern Europe (CEE) had a robust 2019 year, displaying resilience in the face of global economic headwinds, according to new research from Mazars in association with Mergermarket. The report, Investing in CEE: Inbound M&A Report 2019/2020, offers an overview of inbound M&A activity in the CEE region throughout 2019 and looks ahead to the opportunities and challenges in the coming months.

"Location is a clear competitive advantage, with the more developed economies of Western Europe on one side, and the fast-growing markets of Asia and the Middle East on the other. For many investors, the region brings some of the benefits of both." - Michel Kiviatkowski, CEE Leader of Financial Advisory Services at Mazars

#### **KEY FINDINGS**

- The region is attractive for investors thanks to its unique combination of competitive advantages: a strategic location bridging western Europe with Asia and the Middle-East, a strong pool of talent, relatively low costs compared to more developed markets and a growing middle class.
- CEE's economy continued to move forward at a healthy pace in 2019, despite global economic headwinds such as the trade war between the US and China, an inversion in the US bond yield curve and a slowdown in Eurozone's economies.
- The four main factors influencing transactional activity in the *region were:* the strong international appetite from strategic buyers to invest in CEE, the increasing Private Equity interest for the region, succession planning and market consolidation in a few sectors.
- €42.3 billion, with a total number of 726 deals.
- Meanwhile, median EV/EBITDA multiples rose from 6.74x in 2018 to 7.81x in 2019 (compared to 10.91x in Western Europe).
- Private Equity activity in CEE continued to develop, with a total of 69 PE buyouts deals in 2019 (€2.9 billion). PE exits were registered at 59 in 2019, with a disclosed total transaction value amounting €6.5 billion. International PE players were mainly involved in larger transactions, whereas local PE firms tended to focus more on small and mid-sized transactions.

- Inbound M&A deals involving strategic and financial investors coming from outside the CEE counted for 40% of CEE M&A deal volume and 51% of CEE M&A deal value.
- International buyers were coming mainly from Western Europe, the USA and Asia. The external shock of the ongoing Covid-19 outbreak is highly likely to have a substantial impact on CEE's economies and its M&A market in 2020, as it will across the world. An economic slowdown was already expected in Europe, even before the current crisis exacerbated the matter. Nonetheless, the M&A market in the CEE is relatively well-positioned to weather the crisis, in comparison to other emerging market regions.
- Once a semblance of normalcy returns, the CEE's strong fundamentals will contribute to ensure that Central & Eastern Europe will remain attractive to investors.



- Agree to apply the form of working from home and/or utilize the employees' annual leaves in accordance with the labor laws and policies of the employers to enjoy full salary.
- Agree to suspend working and enjoy the salary for work suspension consented by the two parties in accordance with the regulations of laws.
- Agree to take unpaid leaves.

As businesses continue to navigate and adapt to the Covid-19 epidemic, many are asking how best to manage their labour force as businesses are inevitably slowing for most. Mazars Vietnam has compiled a list of frequently asked questions relating to labor issues below:

Theoretically, the reduction of working days/hours and employe salary is only permitted upon mutual agreement between employer and the employee. It is worth noting that the reduc working hours are considered work suspension duration according to the laws, in case of work suspension due to danger epidemic diseases, the salary for work suspension shall be agree by the two parties but must not be lower than the regio minimum salary stipulated by the Government.

#### 4. Is the employer able to unilaterally terminate la contracts with employees?

Pursuant to the laws, "if, as a result of natural disaster, fire or another force majeure event as prescribed by laws, the employers, though **OUR SUPPORT** having applied every remedial measure, have to scale down production and cut jobs", the employers are entitled to unilaterally terminate We do trust the above points are notable and sufficient, but should labor contracts with employees. However, the employers must you have any questions or need a deeper discussion on this issue, prove that they have applied necessary remedial measures (such please do not hesitate to contact Mazars Vietnam. as reaching mutual agreements with the employees on salary reduction or unpaid leave, etc.) but still have no choice other than cutting jobs. In this case, the employers shall still have to follow provisions on advance notice and payment of severance allowance to the eligible employees.

#### 5. What are the policies the government is introducing to help businesses during this time?

#### UPDATES ON **VISA RESTRICTIONS & RECOMMENDATIONS** FOR FOREIGN INDIVIDUALS RESIDING OR TRAVELING **IN VIETNAM**

11th March 2020 Vlad Savin

Due to the Coronavirus worldwide outbreak and the recent cases which appeared in Vietnam, the authorities have temporarily updated Visa restrictions and provisions for foreign individuals entering, exiting Vietnam.

There is a high chance that visa applications from individuals with the following passports will be not permitted: UK (GBR) - France (FRA) - Germany (D) - Sweden (SWE) - Italy (ITA) - China (CHN) - Spain (ESP) - Denmark (DNK) - Norway (NOR) - Finland (FIN) -Korea (KOR) – Macau (CHN)<sup>2</sup>.

Foreign individuals who already have visa letter, visa sticker, 5 - year exemption or TRC might not be able to enter Vietnam or will be asked for government quarantine if they have travelled to European countries and other highly affected areas starting from February 2020, or if they did not pass the entry point's health check.

Business visa letters can only be approved when the individual has a sponsor company (no agency) and their visa issue location is airport or Vietnam embassies/consulates (no land border). Airport letters are only issued if the country they are flying from doesn't have Embassy/ Consulate.

Foreign individuals already in Vietnam are recommended to not leave the country to extend their visas, but to apply for visa extension whilst in Vietnam, in order to avoid potential complications that may arise within the process of exiting/entering the country. The fee will likely be higher than usual and may vary widely, upon the offerings of various immigration agents.



<u>Declaration</u>" for foreign individuals entering Vietnam. The form is available in English, Chinese, Korean, Italian, Cambodian, Russian, Spanish, French and Thai. Both apps can be downloaded on Google Play and Apple Store.

App users can update their health status daily. They can also report suspected cases of infection nearby. Health authorities will collect information to identify those needed to be monitored or guarantined, in order to limit the spread of the Covid-19. Furthermore, the government will update the current situation and provide further guidance directly on the mobile applications.

As the situation is continuously evolving and immigration policy changes may occur daily, the regulations released by the authorities will constantly be updated and released to public within media and public communication channels.


